BOAT TRAVEL AND SCUBA DIVING LIABILITY RELEASE AND ASSUMPTION OF RISK AGREEMENT

Please read carefully and fill in all blanks before signing.

I, _____, hereby affirm that I am a certified diver or a student diver under the control and supervision of a certified divemaster or scuba instructor, and that I thoroughly understand the hazards of scuba diving including those hazards occurring during boat travel to and from the dive site (hereinafter collectively referred to as "Excursion"), which may result in serious injury or death. I understand that these hazards include, but are not limited to, air expansion injuries, drowning, decompression sickness, slipping or falling while on board, being cut or struck by a boat while in the water, injuries occurring while getting on or off a boat and other perils of the sea. By signing this release, I certify that I am fully aware of and expressly assume these and all other risks involved in such an Excursion, whether conducted as a recreational dive or part of a diving class.

I understand and agree that neither Lissenung Diving Ltd. – including dive professionals, staff and crew - nor the vessel, nor the vessel owner, nor PADI Asia Pacific, nor its affiliate or subsidiary corporations, nor the owners, officers, employees, agents, or assigns of the above listed individuals and/or entities (hereinafter "Released Parties") may be held liable or responsible in any way for any injury, death or other damages to me, my family, estate, heirs or assigns, that may occur as a result of my participation in this Excursion or as a result of the negligence of any party, including the Released Parties, whether passive or active.

I also understand that skin diving and scuba diving are physically strenuous activities and that I will be exerting myself during this Excursion, and that if I am injured as a result of heart attack, panic, hyperventilation, drowning or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same. I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.

I understand the terms herein are contractual and not a mere recital and that I have signed this Agreement of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree that if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.

I understand and agree that I am not only giving up my right to sue the Released Parties but also any rights my heirs, assigns, or beneficiaries may have to sue the Released Parties resulting from my death. I further represent I have the authority to do so and that my heirs, assigns, or beneficiaries will be stopped from claiming otherwise because of my representations to the Released Parties.

I agree to pay compensation at full current market value to Lissenung Island Resort for any and all damage or loss of property and equipment belonging to Lissenung Island Resort resulting from abuse or negligence on my part.

It is further understood that the remoteness of the destination, local custom and/or prevailing weather conditions may cause minor inconveniences or modification to the diving portions of any tour and Lissenung Island Resort reserves the right to modify and/or cancel diving arrangements due to unfavourable weather conditions and/or technical difficulties.

I understand that, in the event I cancel any of my prepaid dives, I am not entitled to a refund or credit.

The undersigned further acknowledges and agrees that during the diving tour, engaging in spear fishing or collection of marine life such as shells and coral is prohibited and that the undersigned shall not conduct or undertake any activity that is harmful to the marine environment.

If you wish to pre-pay activities to avoid GST, please note that we are unable to refund monies paid should you decide not to participate. In case Lissenung Island Resort has to cancel prepaid activities to unforeseen circumstances, you will receive a full refund.

Cancellation Policy:

- Cancellation more than 30 days prior to arrival – 20% deposit will be forfeit
- Cancellation within 30 days of arrival – no refund is given

Group Booking terms & conditions (6+ persons):

- A non-refundable 20% deposit of the invoice total is required at the time of booking to confirm your reservation. The final payment must be made **45 days prior to arrival** at Lissenung Island Resort. Non-payment will result in cancellation of the reservation.
- Cancellation policy applies as follows:
 - Cancellations more than 45 days prior to arrival - a 20% cancellation fee is charged (non- refundable deposit)
 - Cancellations within 45 days of arrival - no refund is given

General Info

Papua New Guinea is in many ways still a 3rd world country. Many things that can be readily bought in the western world are often unavailable in PNG. Especially the ability to purchase certain food items can vary from one week to another as just about everything is shipped in.

If you have special dietary requirements, please let us know as soon as possible, so we have plenty of time to buy special food items for you, if possible. It might also be a good idea to bring your own, especially if there are things that are essential to you. Obviously, customs regulations must be adhered to, so please check those. You might also like to check with us what is readily available here and what isn't.

Beer, Wine and Softdrinks are available for purchase at the resort, but spirits are extremely expensive and often not in stock. Please feel free to bring your own, maybe from the duty free shop. We have plenty of mixer drinks and ice.

Malaria can be an issue in PNG, so please talk to your doctor about taking a malaria prophylaxis. Please advise the doctor if you will be diving. Mosquito repellent will help you keep the mozzies at bay, but light-weight long-sleeved tops and pants come in very handy, also. Our rooms all have mosquito screens and nets.

A small medical kit with antibiotic cream and/or tablets, ear- and eye drops, band aids, antihistamine tablets etc. is a very useful tool in the tropics. Please also ensure that you bring any personal medication with you that you may need as our local pharmacy has, once again, only rather limited stock.

There are no street lights on Lissenung, so please bring a torch to help you find your way back to your room in the dark.

Make sure that your dive gear is in good order, had a recent service and that you carry some spare parts. Most importantly, don't forget to bring your certification card and logbook !!

If you would like to bring something for the kids in the village, cheap tennis balls or swimming goggles are always a hit, but exercise books for school, pens, pencils, pencil sharpeners and books (colour-in, learning number or the alphabet) are always greatly appreciated, too. If you are planning on cleaning out your wardrobe soon, why don't you do it prior to your holiday and take those clothes that you were going to give away for a final wear? At the end of your stay, you can leave them behind and we'll hand them out during the Lissenung Island Resort Staff Christmas Party. Our staff will get a new set of clothes (they love clothes from other countries), and you'll have more space in your suitcase to take home souvenirs!

We also collect glasses for the local hospital, so if you have old spectacles lying around, or have friends and family who might be able to assist, please bring them with you. The hospital can check the strength of the glasses and hand them out accordingly.

Last but not least, a word on tipping. In many countries, this is an important custom and people in the service industry rely on these tips. In PNG, tipping is generally not expected, but none the less, it's very much appreciated. If you feel that our staff members have provided you with great service, feel free to tip whatever you feel comfortable with. There is no set amount or percentage. If you don't want to tip, that's okay, too.

We do ask, however, that you give the tip to us, not to the staff directly. We will ensure that everyone gets his/her fair share of it.
